## **BYLAW 7/99**

## A BYLAW TO CONVERT BUSINESS TAX TO A LICENCE FEE

The Council of the Town of Craik in the Province of Saskatchewan, enacts as follows:

- 1. All taxes in respect of the assessment of the insurance business carried on within this town shall be deemed to be a licence fee.
- 2. A person whose business tax has been constituted a licence fee as provided in section 1, shall forthwith after notice of the adoption of this bylaw has been published in The Craik Weekly News apply to the Clerk of this town for a licence in respect of the business carried on or engaged in by him/her.
- 3. The Clerk is hereby authorized to issue a licence in respect of an application made under section 2 where such application is accompanied:
  - (a) in the case where the business tax has been determined for the year, by payment of the full licence fee; or
  - (b) in the case where the business tax has not been determined for the year, by payment of an amount equal to the tax determined for that business in the preceeding year; or
  - (c) in the case where no business tax in respect of that business was determined in the preceding year, by payment of the estimated total tax as determined by the council, the amount of which estimated total tax shall not exceed the licence fee payable in respect of any similar business.
- 4. In cases where there is a balance payable by reasons of an adjustment as provided in section 3, clause (b) or (c), such balance shall be paid within thirty days of the date of mailing of the tax notice.
- 5. No person whose business tax has been constituted a licence fee shall engage in, operate, or carry on such business within this town unless he/she shall have obtained from the Clerk of this town a licence for such business in accordance with the provisions of this bylaw.
- 6. A person who contravenes the provision of this bylaw is guilty of an offence and upon summary conviction shall be liable to the penalty provided for by the general penalty bylaw of the municipality.


