The Council of the Town of Craik in the Province of Saskatchewan enacts as follows:

- 1. The Council of the Town of Craik, since it has been unable to acquire the lands by agreement with the owner, deems it necessary to acquire title to the above noted lands for the purpose of the maintenance and enhancement, as necessary of a drainage ditch constructed on a portion of the above noted lands, which drainage ditch prevents flooding of the town and its residents form surface water runoff and for the purpose of maintenance and enhancement of a roadway constructed on a portion of the lands which provides for the means of ingress and egress for residents of the town and inhabitants of the rural arrears surrounding the Town.
- 2. The Town of Craik, pursuant to the authority granted to it in The Municipal Expropriation Act hereby expropriates from Ilenna Luzny, the registered owner of the above noted lands, all of her right title and interest in the following land:


